GS1 is a not-for-profit organisation that develops global standards for the identification of goods and services.



Global standards for automatic identification
Rapid and accurate item, asset or location identification



Global standards for electronic business messaging
Rapid, efficient & accurate business data exchange



The environment for global data synchronisation
Standardised, reliable data for effective business transactions



Global standards for RFID-based identification
More accurate, immediate and cost effective visibility of information

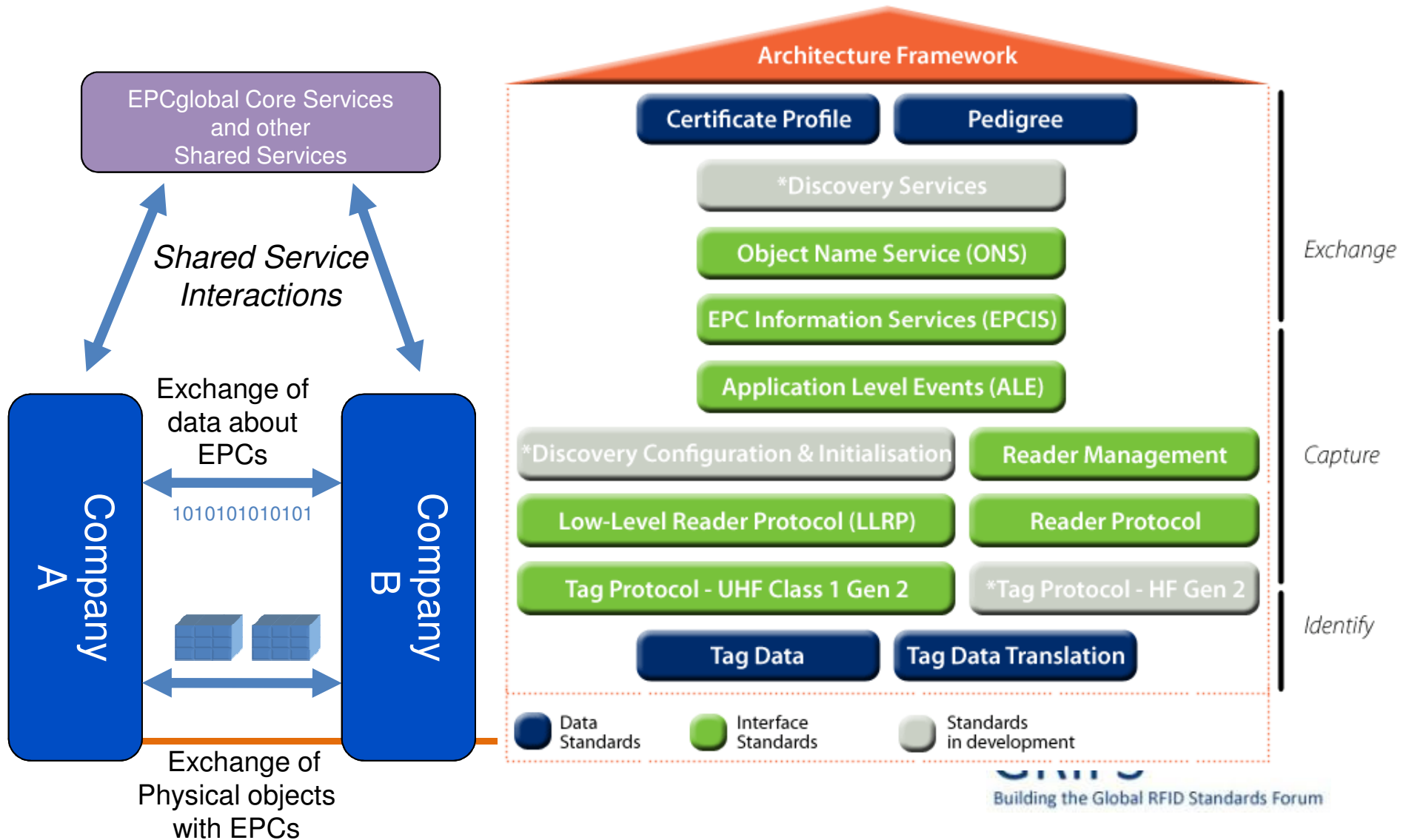

- *GRIFS = Global RFID Interoperability forum for Standards*
- European Union funded support action
- Duration: January 2008 to December 2009 (2 years)
- Members: GS1 (Coordinator), ETSI, CEN
- Objectives:
 - Document RFID standards activities globally
 - Establish liaisons with on-going projects and Standard bodies
 - **Establish a global forum for RFID Standards**

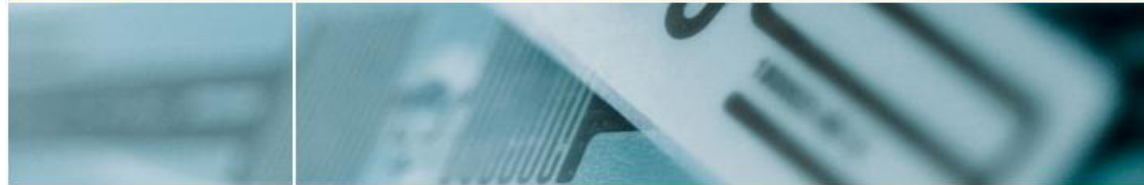

Why is GRIFS important?

- RFID (in the broadest sense) has still many opportunities for standards development
- Too many initiatives, not enough consistency
- Important to understand User requirements, cannot expect Users to attend all standards forums/activities
- A voluntary coordination effort is the optimal approach to address this issue
